Services of Funeral Director and Staff

Basic Services of Funeral Director and Staff \$2,595

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. The fee is already included in our charge for direct cremations, immediate burials and forwarding or receiving of remains.

- Personnel available 24 hours a day, 365 days a year to bring your loved one into our care.
- Consultation with family and coordination of service plans.
- Accounting and general clerical administration.
- Securing and recording the death certificate and obtaining the permit for disposition.
- Coordination of service plans with cemetery, crematory and/or other parties involved in the disposition.
- Basic coverage of overhead expenses such as facility and equipment maintenance, equipment and inventory costs, insurance, and governmental compliance.
- Coordinating with the military to establish eligibility in a National Cemetery and schedule burial when applicable
